3. PUBLIC COMMENT ON NON-AGENDA ITEMS – 6:05 p.m.

<u>Julianne Gale</u> – Julianne spoke about STR regulations being a positive step forward for long-tern rentals and ensuring all residents of Mason County have accessible housing.

<u>Jacob Ackley</u> – Jacob urged the PAC to consider affordable housing options for Mason County.

4. PUBLIC HEARING continued from 10/21 – 6:08 p.m.

Mason County Comprehensive Plan Periodic Update 2025: County Wide Planning Policies – Kirsten Peterson with SCJ Alliance began by going over schedule for the Comp Plan. Commissioner Harris confirmed that TIPCAP will be involved in the Transportation section and asked about the Climate Policy Action Team. Kirsten explained that the CPAT is made up of several local stakeholders and residents and will be meeting to discuss and create the Climate Action chapter to bring before PAC. Commissioner Carey asked for brief updates of their meetings along the way so when they get to their review, they have some background.

Kirsten then went over the proposed Table of Contents and gave an overview of the purpose of the Countywide Planning Policies. She also gave examples of how the policies then get implemented throughout the Comprehensive Plan as goals and objectives.

PAC members then went through the comment matrix provided by staff and the suggested changes to the CPPS to make final changes to the document. Discussion focused on the high-level nature of the CPPs and making the document as concise and easy to understand as possible. The following changes were agreed on:

Public Participation 11.1	Add "widespread community" and remove "of residents, property owners, and business owners" "Encourage the widespread community involvement of residents, property owners, and business owners in the planning process"	Consultant suggested "widespread community" to keep broad and inclusive
Public Participation 11.3	Add new section – "Ensure public participation is widespread to community members."	
Climate Change and Resiliency 14.2	Add "Prioritize mitigating the impacts on vulnerable populations and overburdened communities within the planning period."	MCCJ suggested for compliance with RCW 36.70A.070
Climate Change and Resiliency 14.3	Add "infrastructure" "operations, infrastructure, and system recovery."
