Auditor's Monthly Financial Report

June 25, 2024

Mason County is operating on an approved budget of \$72,294,546. These funds include a beginning cash balance of \$28,000,000 and cover the Sheriff's department, administrative functions, operations of various offices and departments, and the courts. The Board of County Commissioners approved a Public Hearing on June 18, 2024, for requested supplemental appropriations of \$770,821 for General Fund & \$2,556,821 for Funds other than the General Fund. The tables below summarize expenditures and revenues through May 31, 2024.

Debt

Outstanding debt for the County as of May 31, 2024, is \$15,700,746.43 Most of which is in the form of Limited Tax General Obligation Bonds. Most debt payments have interest payments due on June 1 and principal and interest payments due on December 1, 2024.

Cash Balance

Mason County closed May 2024 with General Fund reserves of \$29,213,875.05. These funds are largely invested by the Treasurer in the Local Government Investment Pool.
