Mason County is updating its Shoreline Master Program (SMP) to comply with the Washington State Shoreline Management Act and current state shoreline management guidelines. The SMP regulates waterbodies considered to be "shorelines of the state" which are rivers, streams, and lakes of a certain size as well as marine waters. Regulated shorelines of the state are defined as lakes larger than 20 acres; streams and rivers with a mean annual flow greater than 20 cubic feet per second; and marine waters. The SMP also regulates property adjacent to the shorelines of the state. This includes property within 200 feet of the ordinary high water mark; 100-year floodplains and associated wetlands. If you have received this mailer you are probably an owner of shoreline property. As members of the public your involvement is crucial in shaping the future of our shorelines.
