RCW 36.48.070 County finance committee — Approval of investment policy and debt policy — Rules.

The county treasurer, the county auditor, and the chair of the county legislative authority, ex officio, shall constitute the county finance committee. The county treasurer shall act as chair of the committee and the county auditor as secretary thereof. The committee shall keep a full and complete record of all its proceedings in appropriate books of record and all such records and all correspondence relating to the committee shall be kept in the office of the county auditor and shall be open to public inspection. The committee shall approve a county investment policy and a debt policy and shall make appropriate rules and regulations for the carrying out of the provisions of RCW 36.48.010 through 36.48.060, not inconsistent with law.





Washington State Treasurer Duane Davidson Hails National Award For Financial Reporting

Local Government Investment Pool Continues Strong Performance

For its most recent annual update on how Washington state invests surplus funds of more than 500 local governments, the Office of the State Treasurer (OST) has earned a Certificate of Achievement for Excellence in Financial Reporting. The honor was granted earlier this month by the Government Finance Officers Association of the United States and Canada, for OST's Fiscal Year 2016 Comprehensive Annual Financial Report (CAFR) on Washington's Local Government Investment Pool (LGIP). State Treasurer Duane Davidson hailed the honor, and said it reflects the diligence and professionalism of OST's staff.

Davidson said, "Fiscal 2016 marked the 20th year in a row that our state's Local Government Investment Pool's financial report has received this prestigious recognition. This honor was earned for work done during the tenure of my predecessor James McIntire, and earlier versions of the award were won by OST under a series of his predecessors. It is a window into – and strong reminder of – the professionalism and dedication of our operation at OST. Our team of 65 staff members smoothly handles enormous responsibilities. They keep state tax dollars safe, secure and liquid; and provide banking, investment and borrowing services for the state, and local governments."

Davidson added, "Our office's trustworthy accounting serves to daylight our work for the public, and goes above and beyond baseline professional standards. Accountability is more than just a talking point, it's a way of doing the public's business."

The association's <u>criteria for awarding the certificate</u> emphasize "the spirit of transparency and full disclosure," and recognizing "individual governments that succeed in achieving that goal." The awards are granted after review by select association staff and a special panel of public sector finance experts, other finance professionals, independent auditors, and academics.

<u>The OST report</u> shows that the state's LGIP had an average balance invested during FY 2016 of \$10.5 billion. It yielded net investment income of \$33.8 million. That was \$27 million, or five-fold more than what had been expected under the industry-standard benchmark.

Washington state lawmakers created the LGIP in 1986 so that eligible government taxing bodies could invest their temporary cash surpluses at scale, to earn a competitive rate of return while still maintaining 100 percent liquidity. Currently, more than 530 local governments invest in Washington's LGIP. They include all 39 counties, 234 towns and cities, 160 special taxing districts, 30 community colleges and universities, seven state agencies, and 24 others.

Treasury discontinued the 20-year constant maturity series at the end of calendar year 1986 and reinstated that series on October 1, 1993. As a result, there are no 20-year rates available for the time period January 1, 1987 through September 30, 1993.

Treasury Yield Curve Rates. These rates are commonly referred to as "Constant Maturity Treasury" rates, or CMTs. Yields are interpolated by the Treasury from the daily yield curve. This curve, which relates the yield on a security to its time to maturity is based on the closing market bid yields on actively traded Treasury securities in the over-the-counter market. These market yields are calculated from composites of quotations obtained by the Federal Reserve Bank of New York. The yield values are read from the yield curve at fixed maturities, currently 1, 3 and 6 months and 1, 2, 3, 5, 7, 10, 20, and 30 years. This method provides a yield for a 10 year maturity, for example, even if no outstanding security has exactly 10 years remaining to maturity.

Treasury Yield Curve Methodology. The Treasury yield curve is estimated daily using a cubic spline model. Inputs to the model are primarily bidside yields for on-the-run Treasury securities. See our Treasury Yield Curve Methodology page for details.

Negative Yields and Nominal Constant Maturity Treasury Series Rates (CMTs). Current financial market conditions, in conjunction with extraordinary low levels of interest rates, have resulted in negative yields for some Treasury securities trading in the secondary market. Negative yields for Treasury securities most often reflect highly technical factors in Treasury markets related to the cash and repurchase agreement markets, and are at times unrelated to the time value of money.

As such, Treasury will restrict the use of negative input yields for securities used in deriving interest rates for the Treasury nominal Constant Maturity Treasury series (CMTs). Any CMT input points with negative yields will be reset to zero percent prior to use as inputs in the CMT derivation. This decision is consistent with Treasury not accepting negative yields in Treasury nominal security auctions.

In addition, given that CMTs are used in many statutorily and regulatory determined loan and credit programs as well as for setting interest rates on non-marketable government securities, establishing a floor of zero more accurately reflects borrowing costs related to various programs.


