# Housing and Behavioral Health Advisory Board's recommendations to the Board of County Commissioners:

### Housing & Homelessness:

- **Priority #1:** Create Permanent Supportive Housing Units Housing Types with Mental Health Services
- **Priority #2:** Create Permanent Supportive Housing Unites Housing Types that prevent the need for shelter
- Priority #3: Increase emergency shelter capacity Family Shelter
- Priority #4: Increase emergency shelter capacity Household without children
- Actions/Recommendations:
  - BOCC to adopt HB1590
  - County-City joint project

### Behavioral Health/Substance Use Disorder:

- **Priority #1:** Crisis co-responder programs coupled with law enforcement
- Priority #2: Sustainability of jail substance use and re-entry services
- Priority #3: Sustainability of Behavioral Health Transportation Program
- Priority #4: Increase detox beds for youth
- Actions/Recommendations:
  - Partner with a licensed Behavioral Health Agency (i.e., OHRS) for sustainability of jail SUD and re-entry services; increase 0.5 FTE peer to 3.0 FTE

• Permanent funding allocation for Behavioral Health Transportation Program

#### Mental Health:

- **Priority #1:** Increase crisis stabilization beds
- **Priority #2:** Conduct a comprehensive, multi-system (homeless, behavioral health, and mental health care) study to identify needs and gaps
- **Priority #3:** Increase crisis response capacity
- Actions/Recommendations:
  - Mason County DCR piloted through July 2023 (City of Shelton allocated grant); co-responder program with MCSO & SPD to grow/expand crisis services
  - Move upstream into schools to increase Navigator engagement with youth and families
  - Engage Shelton School District Wellness Coordinator; increase county support to bridge gaps with other smaller school districts (education, awareness, Spanishspeaking resources)
  - Conduct quantitative and qualitative analysis of Behavioral Health program deliverables and outcomes to measure the impact of interventions/program activities; determine gaps and opportunities to modify/improve
