**Ballots in Envelopes**

- (75) Received too late – Ballots received after 8:00 pm March 12, 2024**
- (116) Mismatched signature - Signature on envelope does not match signature on voter registration file**
- (49) No Signature on envelope – Voter did not sign the ballot**
- (532) No Party Choice or Modified Declaration – Voter did not mark a party on the envelope or voter modified the party declaration**
- (12) Empty envelopes – Voter returned outer envelope with no ballot inside**
- (4) Other than Voter – Someone else signed the voter’s envelope**
- (13) Both Party Boxes Marked with Signature**
- (1) No ID of Voter – Ballots received with no identification of voter**
- (1) Pending Potential Felon – is incarcerated in D.O.C. September 2023**


