RE: Seeking members for 1/10th of 1% Sales & Use Tax for Mental Health, Substance Abuse, and Therapeutic Court Advisory Committee

The Mason County Commissioners are seeking volunteers to serve on an Advisory Committee which will review reports and data regarding the mental health and substance abuse needs in Mason County. Additionally, the Advisory Committee will identify and review current mental illness/substance abuse services — public and private, and determine the gaps in services. The Committee will look at the cost drivers for mental illness and substance abuse issues in the criminal justice system. The Committee will identify and review best practices, evidence-based, and promising practices for prevention and treatment services. The Committee will also select a fund allocation system that assures fairness and cost effectiveness as well as an evaluation/quality improvement process and an effective reporting system that includes an annual report to the citizens of Mason County if the Committee recommends that the sales and use tax be implemented.

The Advisory Committee will hold public meetings and seek input for consideration in their final report. They will also present their findings and recommendations in a series of community meetings.

The Advisory Committee will be staffed by a facilitator who will prepare discussion materials and write a final report based on the work of the Committee and to be approved by the Committee and forwarded on to the County Commissioners for their consideration. The report will contain recommendations on the implementation of the Sales and Use Tax authorized by the Legislature to address mental health and substance abuse treatment issues at the county level.

It is anticipated that this work will be completed within a relatively short timeframe and the report will be presented to the County Commissioners by September 13, 2011.
