RESOLUTION OF INTENTION TO VACATE
PORTION OF OLD ARCADIA ROAD NO. 9310

WHEREAS, the Arcadia Road was relocated in 1965, rendering a portion lying northerly of the existing location unused in Section 25, Township 20 North, Range 3 West, W. M.; and

WHEREAS, at the request of the County Engineer, the Board of County Commissioners hereby RESOLVE that the following described portion of said Old Arcadia Road No. 9310 right-of-way be abandoned in accordance with RCW 36.87.010 and revert to the owners of the adjacent property:

"That portion of the Old Arcadia Road No. 9310 located in the NE of the NW, Section 25, Township 20 North, Range 3 West, W. M., beginning at Engineers Station 212+00 through Engineers Station 215+50 and lying thirty (30) feet north of the center line of the existing road as constructed in 1965, and shown on the official map for this project, on file in the office of the Mason County Engineer."

FURTHER, the Commissioners do hereby instruct the Clerk to prepare and publish a Notice of Hearing on said proposed abandonment; said Hearing to be held in the County Commissioners Office in the Courthouse at Shelton, Washington, at 11:00 A.M., Monday, April 13, 1970, and that the County Engineer be directed to submit a written report relative to the abandonment of the aforementioned portion of Old Arcadia Road No. 9310.

ORDER OF VACATION
Road Vac. File No. 75

IN THE MATTER OF THE VACATION OF: That portion of the Old Arcadia Road No. 9310, described as follows:

"That portion of the Old Arcadia Road No. 9310 located in the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 25, Township 20 North, Range 3 West, W.M., beginning at Engineers' Station 212+00 through Engineers' Station 215+50 and lying thirty (30) feet north of the center line of the existing road as constructed in 1965, and shown on the official map for this project, on file in the Office of the Mason County Engineer."

FIRST: That according to RCW 36.87, the Board of County Commissioners did, on March 23, 1970, unanimously declare their intention to abandon the above described portion of County Road by Resolution.

SECOND: That a Hearing was set for 11:00 A. M., Monday, April 13, 1970, Notice of which was duly published and posted on the ground.

THIRD: That at said Hearing, the County Engineer presented a written report recommending the abandonment of the above described portion of County Road No. 9310.

FOURTH: At said Hearing no one appeared to object to the Vacation of said Right-of-way and its return to the adjacent land owners, and the Clerk was unanimously directed to draw up an Order of Vacation for the closure of said portion of Old Arcadia Road No. 9310.

IT IS HEREBY UNANIMOUSLY ORDERED BY THE BOARD IN SESSION that said portion of Old Arcadia Road No. 9310, being more fully described above,

BE, AND HEREBY IS, VACATED, according to the provisions of the law heretofore cited and that said Vacated right-of-way revert to the adjoining property owners and be returned to the Tax Rolls.
