RESOLUTION NO. 146

FORMATION MASON COUNTY FIRE PROTECTION DISTRICT NO. 13

WHEREAS, an election was held on January 19, 1971, for Cloquallum and a portion of Isabella Precinct (two sections), at which election the voters in the Precincts voted upon the formation of Mason County Fire Protection District No. 13; and

WHEREAS, all of said requirements relating to the formation of Fire Protection Districts, under Chapter 52.04, RCW, have been accomplished; and

WHEREAS, the official canvass of said election shows 46 votes for and 1 vote against the formation of the district; and

WHEREAS, the votes cast favoring the establishment of the district were in excess of 3/5 of the total votes cast;

NOW, THEREFORE, BE IT HEREBY RESOLVED, that Mason County Fire Protection District No. 13, be and hereby is declared established, and the following territory is hereby included therein:

Beginning at the S.W. corner of Section 36, Township 19 North, Range 6 W.W.M., thence north 3 miles to the N.W. corner of Section 24; thence east 1 mile to the N.E. corner of same; thence north 2 miles to the N.W. corner of Section 7, Township 19 North, Range 5 W.W.M.; thence east 3 miles to the S.W. corner of Section 3; thence north 1 mile to the N.W. corner of same; thence east 7 miles to the N.E. corner of section 3, Township 19 North, Range 4 W.W.M.; thence south 2 miles to the S.E. corner of Section 10; thence west 3 miles to the S.W. corner of Section 8; thence south 3 miles to the S.E. corner of Section 30; thence west 1 mile to the S.W. corner of same; thence south 1 mile to the S.E. corner of Section 36, Township 19 North, Range 5 W.W.M.; thence west 7 miles to the place of beginning; which includes these sections: Sections 1, 2, 3, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, and 36. All subdivisions at Star Lake, Arrowhead Lake and Lost Lake in Township 19 North, Range 5 West W.M., and Sections 3, 4, 5, 6, 7, 8, 9, and 10, Township 19 North, Range 4 West, W.M. All located in Mason County, Washington, and also Sections 24, 25, and 36 in Township 19 North, Range 6 West, W.M., and also Sections 18, 19, and 30 in Township 19, Range 4 W.W.M., being situate in Mason County, Washington.

AND, FURTHER, that the following three Commissioners receiving the highest number of votes at said election are hereby declared the first Board of Commissioners of said Fire District:
