

RESOLUTION NO. 252

(To correct the outer boundaries of Eells and Union Precincts.)

WHEREAS, a review of all Voting Precinct boundaries (as described in Mason County Code book under Title 1, Chapter 1.12 and covering Sections No. .010 through .500 on pages 3 through 23 therein) has been made; and

WHEREAS, the descriptions of the outer boundaries of the two above-named Precincts do not properly describe the existing boundaries of said Precincts as shown on the current County Precinct Maps; and

WHEREAS, the errors appear to be typographical errors, committed during the process of printing the above-described Code Book; and

WHEREAS, it becomes necessary to re-write the descriptions of both Eells and Union Precincts as currently shown in the Mason County Code book under Sections 1.12.080 (Eells) and 1.12.250 (Union) to agree with the existing map boundaries;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the code descriptions be re-written to conform with the outer boundaries of said Precincts as shown on the current Precinct maps, and that the Code Book be corrected accordingly, by the following corrected descriptions. (Attached)

The outer boundaries of EELLS Precinct, in Mason County, Washington, shall hereafter be described as follows:

Beginning at the Southwest corner of Section 31, Township 21 North, Range 5 West W.M. (being the Southwest corner of the Township and located on the 5th Standard Parallel); Run thence North 6 miles along the West Township line, to the Northwest corner thereof; thence East (along the line common to Townships 21 and 22) 4 miles to the Southwest corner of Section 35, Township 22 North, Range 5 West W.M.; thence North 1 mile to the Northwest corner of said Section 35; thence East (along Section lines) 5 miles to the Northeast corner of Section 33, Township 22 North, Range 4 West, W.M.; thence South 3 miles, more or less, to Mid-channel of the Skokomish River; thence following said Mid-channel in an Easterly direction to its intersection with the East line of Section 15, Township 21 North, Range 4 West, W.M.; run thence South 3½ miles, more or less, to the Southeast corner of Section 34, said Township and Range; thence West along the Township line (being also the 5th Standard Parallel) for a distance of ten (10) miles to the point of beginning.

* * * * *

The outer boundaries of UNION Precinct in Mason County, Washington, shall hereafter be described as follows:

Beginning at a point where the Mid-channel of Hood Canal intersects with the line between Ranges 2 and 3 West, W.M. (projected North); run thence South (along said projection and the Range line), approximately 3 miles to the Southeast corner of Section 1, Township 21 North, Range 3 West, W.M.; thence West 5 miles to the Southeast corner of Section 6, same Township and Range; thence South one mile to the Southeast corner of Section 7, Township 21 North, Range 3 West, W.M.; thence West one mile to the corner common to said Section 7 and Section 12, Township 21 North, Range 4 West, W.M.; run thence South (along the Range line) two miles to the Southeast corner of Section 24, Township 21 North, Range 4 West, W.M.; thence West two miles to the Southwest corner of Section 23; thence North along the West lines of Sections 23 and 14, above Township and Range, to an intersection with Mid-channel of the Skokomish River; run thence down Mid-channel of said river in a general Easterly and Northerly direction to navigable water of Hood Canal; continue thence in a Northeasterly direction to a point where a line drawn between Bald Point (on North Shore) and the point at Union (on South Shore) would intersect with the said Mid-channel of Hood Canal; thence continue along said Mid-channel, in an Easterly and Northerly direction, to the point of beginning.
