EMERGENCY BUDGET EXTENSION

WHEREAS, according to a Notice of Hearing, adopted by the undersigned on January 23, 1978 declaring there were insufficient funds in the 1978 Sheriff's Department budget to cover construction of a fire escape at west wall of the existing courthouse, and

WHEREAS, in the judgement of the Board of County Commissioners it is in the best interest of Mason County that provision be made for the requested Emergency Budget Extension in the following amount:

Construction costs - - \$10,000.00
