IN THE MATTER OF THE VACATION OF: That portion of Old PSH #9 Jorsted Creek transferred to Mason County on August 25, 1938, and not utilized in the construction of the present Jorsted Creek Road as established by the Board of Mason County Commissioners August 7, 1978.

FIRST: That according to RCW 36.87, the Board of County Commissioners did, on August 7, 1978, declare their unanimous intention to abandon the above described portion of County Road.

SECOND: That a Hearing was set for 10:30 A.M. August 28th, 1978, Notice of which was duly published and posted on the grounds.

THIRD: That at said Hearing on August 28th, 1978, the County Engineer presented a verbal report recommending the abandonment of the above described portion of the present Jorsted Creek Road; and

FOURTH: At said Hearing no one appeared to object to the Vacation of said portion of road and its return to the adjacent property owners, and the Clerk directed to draw up an Order of Vacation for the closure of said portion of Jorsted Creek Road.

IT IS HEREBY UNANIMOUSLY ORDERED BY THE BOARD IN SESSION that said portion of Jorsted Creek Road, being described above,

BE, AND HEREBY IS, VACATED, according to the provision of the law heretofore cited and that it revert to the adjoining property owners and be returned to the Tax Rolls.
