

RESOLUTION NO. 1281

SPEED LIMIT - Shorecrest

WHEREAS, the speed limits on County roads in Mason County, Washington were fixed by Resolution on January 9, 1956, as 35 miles per hour, except certain roads as otherwise posted; and,

WHEREAS, on November 5, 1962, said Resolution was amended to fix the maximum speed limit of 45 miles per hour on all County roads, unless otherwise posted; and,

WHEREAS, existing conditions on the following roads do warrant the speed limit as indicated below:

- #2090 Crestview Drive from the intersection of Agate Road #2391 to the intersection of Parkway Blvd #2011 35 mph
- #2090 Crestview Drive the remainder of this road and that portion of #2090 where the name changes to Shorecrest Drive 25 mph


All other roads in the Shorecrest area as listed below: 25 mph


