

RESOLUTION NO. 52-86

FAIRGROUNDS RENTAL FEES

WHEREAS, the Board of Mason County Commissioners adopted Resolution #5-84 on January 9, 1984 to establish rental fees at the Mason County Fairgrounds; and

WHEREAS, the Board of Mason County Commissioners held a public hearing on June 3rd, 1986 for consideration of amending the resolution for establishing fees for the arena grandstand area at the west end of the fairgrounds; and

WHEREAS, it is necessary to amend the rental fee schedule to include the arena grandstand area at the west end of the fairgrounds;

NOW, THEREFORE BE IT HEREBY RESOLVED that the Board of Mason County Commissioners amends Resolution #5-84 and establishes the Mason County Fairgrounds Rental Fee Schedule as outlined below:

OR 10% (5% for Nonprofit Organizations) of renter's gross receipts received, whichever is greater.

Entire Fairgrounds within the Fence Per Day 350.00

OR 10% (5% for Nonprofit Organizations) of renter's fees received from concessionaires and gate receipts, whichever is greater.

PLUS electricity from the time the renter starts setting up until the day after the event ends. The renter is responsible for cleaning all grounds including parking lot and the bathrooms during and after the event. The renter has two days after the event is over to clean the buildings, grounds, parking lot and make any repairs needed. The renter will be charged for any clean up done by fair staff after the renter has had ample time allowed according to manager's discretion. This will include a caretaker to assist and handle problems.

STORAGE FEES (3 Month Minimum)

Boats & Trailers (12 Foot Minimum)	Per Foot Per Month	1.00
Cars	Flat Fee Per Month	15.00
Camping Trailers - No Hookups	Flat Fee Per Day	2.50
Camping Trailers - with Electricity	Flat Fee Per Day	3.50

Any other storage will be negotiated by the Manager.

ARENA GRANDSTAND AREA FEES (West End of Fairgrounds)

For all events except motorcycle and motorized vehicle events Per Day 200.00

OR 15% of all gross receipts (10% of all gross receipts for nonprofit organizations) whichever is greater.


