

RESOLUTION NO. 24-91

A G R E E M E N T

MASON COUNTY & REGION 8 PENINSULA TOURISM COUNCIL

THIS AGREEMENT between Mason County, hereinafter referred to as "COUNTY," and the Region 8 Tourism Council, a nonprofit organization, hereinafter referred to as the "REGION 8."

W I T N E S S E T H :

That in consideration of the terms and conditions contained herein, the parties hereto covenant and agree as follows:

- I. The REGION 8 agrees to provide services to the COUNTY as follows:
  - A. Market the tourism potential of the COUNTY via advertising, promotional presentations, personal contact and mailings.
  - B. Encourage the establishment of environmentally and financially sound tourism attractions in the COUNTY.
  - C. Seek alternatives for financing the efforts of the REGION 8.
  - D. Keep the COUNTY representatives to REGION 8 informed about tourism services, programs and resources available to them in the Olympic Peninsula area.
- II. REGION 8 will hold the COUNTY harmless from all claims of every kind and character arising out of or in any way connected with the services given by it for the COUNTY.
- III. It is understood that REGION 8 is an independent contractor and it is not an agent of the COUNTY, and all personnel used by REGION 8 in connection with the rendering of services contemplated by this contract shall be employees of REGION 8 and not the COUNTY, and shall have no claim against the COUNTY for compensation or other benefits available to the employees of said COUNTY.
- IV. This agreement shall be for a term of three (3) months, beginning January 1, 1991.
- V. The COUNTY will pay the REGION 8 for the services to be performed under this contract for the first three (3) months of the 1991 calendar year, a sum not to exceed TWO HUNDRED FIFTY DOLLARS (\$250.00) to be paid at the first of each fiscal year. Funds paid for such services will be used to furnish only the services contemplated by this contract and will not be diverted by the REGION 8 to any other person or used for any other purpose. REGION 8 records of receipt and expenditure of such funds will be made available on request to County officials and the State Auditor for review.
