WHEREAS, the request appears to be reasonable and necessary;


NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Mason County Commissioners that the following amount(s) be transferred:


BE IT FURTHER RESOLVED that the Mason County Auditor be authorized to make necessary transfer entries affecting the District Court budget.



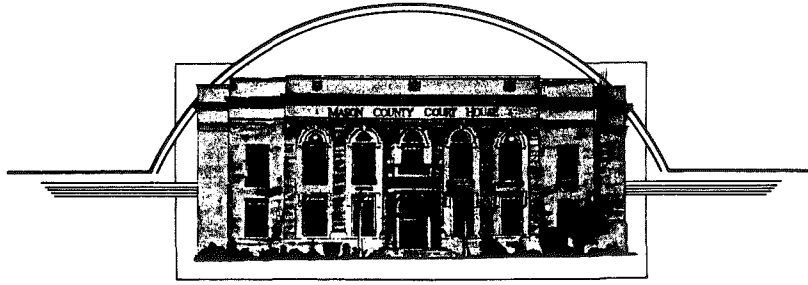
