

RESOLUTION NO. 106A-94

SOLID WASTE FACILITY & DROP BOX STATION RATES

WHEREAS, it is necessary to adjust the rates at the Mason County Solid Waste Facility and Drop Box Stations to meet maintenance and operation costs and to provide required capital for post closure costs, administration, recycling programs, hazardous waste programs, and the costs associated with transportation of solid waste to an out of county location; and

WHEREAS, the Commissioners held a Public Hearing on October 4, 1994 and received public input;

NOW THEREFORE, BE IT RESOLVED, that the below listed rates are adopted as Mason County's Solid Waste Facility and Drop Box Station rates, effective January 1, 1995.

Resolution No. 127-92 is hereby canceled.

DROP BOX STATIONS - BELFAIR/HOODSPORT, UNION RATES

Loose Yardage - cubic yard	\$13.80
Minimum To 30 Gallons - Each	\$ 3.25
Appliances - Each (white goods, couches, chairs, TV's, mattresses).	\$11.00
Refrigerators - Each	\$31.50
Tires(no rim) - Each	\$ 2.90
Tires(with rim) - Each	\$ 6.05

55 Gallon Containers - Each	\$ 6.00
Asbestos - Cubic Yard	\$26.25

MINIMUM RATE:

The minimum rate for solid waste brought across the scale will be \$2.65.

HOUSEHOLD HAZARDOUS WASTE:

Latex Paint, Oil Base Paint, Pesticides

Users will be assessed \$5.00 per vehicle with up to 3 gallons of waste. For every half gallon over 3 gallons the user will be assessed an additional \$.50. The minimum charge is \$.50 for material over 3 gallons.
