

**RESOLUTION NO. 118A-94
RENUMBERING AND RENAMING
COUNTY ROADS (TIMBERLAKES)**

WHEREAS, on October 11, 1994, the Board of County Commissioners did declare their intention to hold a public hearing on Tuesday, October 25, 1994 at 10:30 a.m. to consider renaming and renumbering roads within the Plats of Timberlake as follows;


