

RESOLUTION NO. 87-96  
ESTABLISHMENT OF FAMILY LAW FACILITATOR FUND

WHEREAS, the Board of Mason County Commissioners established a superior court filing fee surcharge and a marriage license fee surcharge to fund a courthouse facilitator program as authorized by RCW 26.12.240 and RCW 26.04.160 (2) (see attachment A which is incorporated as part of this resolution);

WHEREAS, RCW 26.12.240 requires fees or surcharges for courthouse facilitator programs to be maintained in a separate account;

NOW, THEREFORE BE IT HEREBY RESOLVED by the Board of Mason County Commissioners that Fund No. 138-000-010, Family Law Facilitator Fund, shall be established for the receipt of said superior court filing fee surcharges and marriage license fee surcharges.

BE IT FURTHER RESOLVED disbursements from the Family Law Facilitator Fund shall be only for expenses of a courthouse facilitator program.

RESOLUTION NO. 80-96

ASSESSMENT OF SUPERIOR COURT  
FILING FEE SURCHARGE  
AND  
ASSESSMENT OF MARRIAGE LICENSE FEE SURCHARGE

WHEREAS, a Courthouse Facilitator position was created to assist unrepresented individuals with access to the court in divorce, parenting plans/custody, child support, or in family court matters; and

WHEREAS, creation of this position will reduce the workload caused by pro se litigants on certain of the County Clerk's public service duties and improve the quality of and perception of the quality of justice in family court matters in Mason County; and

WHEREAS, the Washington State Legislature, in the 1993 regular session, recognized the impact of pro se litigants on the legal system and authorized county legislative authorities to assess certain Superior Court filing fee surcharges and an additional marriage license fee surcharge to assist with funding of Courthouse Facilitator programs; and

WHEREAS, said additional funding will be provided pursuant to RCW 26.12.240 which authorizes the county legislative authority to assess the imposition of a ten dollar (\$10.00) surcharge on certain Superior Court filing fees, and pursuant to RCW 26.04.160(2) which authorizes the imposition of an additional fifteen dollar (\$15.00) marriage license fee surcharge;

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Mason County Commissioners as follows:

- (a) The Superior Court Clerk is authorized and directed to assess and collect the ten dollar (\$10.00) filing fee surcharge authorized by the 1993, Laws of Washington, Chapter 435, Section 2, on those Superior Court cases filed under Title 26 RCW, and to deposit said surcharges collected as directed by the aforesaid statute;
- (b) The County Auditor is authorized and directed to assess and collect the additional fifteen dollar (\$15.00) marriage license fee surcharge authorized by RCW 26.12.220, and to deposit said surcharge as directed by the aforesaid statute;

(c) The surcharge and user fee so collected shall be placed monthly in a separate account to be used to pay expenses of the Courthouse Facilitator program; and

(d) Effective date shall be July 1, 1996.
