RESOLUTION NO. 158-99 DELETION, COMBINATION AND ESTABLISHMENT OF BUDGETARY, ACCOUNTING FUNDS

WHEREAS, RCW 36.32.120, states "..the board of county commissioners...have the care of the county property and the management of the county funds and business.."

WHEREAS, the Mason County Financial Advisory Committee analyzed Mason County Budgetary/Accounting Funds to improve the efficiency and the effectiveness of the county budgetary/accounting system;

WHEREAS, the Mason County Financial Advisory Committee recommended that certain funds be deleted, combined and/or established;

NOW THEREFORE, the Mason County Board of County Commissioners does hereby:

- Delete Program 001-125-141, Fire Marshal Program, Permit Assistance Center Department, Current Expense Fund. Fire Marshal duties and funding will be absorbed in the Planning Department.
- Establish new Department 001-085-000, Community Development/Special Projects to provide grant project, legislative liaison, and other services for the Board of County Commissioners.
- Delete Fund 100-000-000, Convention Center/Fairgrounds Fund, and establish a new Convention Center/Fair department under Tourism & Recreation in the Current Expense Fund
- Delete Fund 120-000-000, Cumulative Reserve #1
- Delete Fund 125-000-000, Cumulative Reserve Legal
- Delete Fund 136-000-000, Traffic Safety School

- Delete Fund 150-000-000, Personal Health/Nursing; Fund 155-000-000, Health Services Administration; and Fund 196-000-000, Water Quality/Environmental Health. These three funds will be combined into a new Fund 150-000-000, Health Services.
- Delete Fund 162-000-000, Memorial Hall. Memorial Hall will become a program in the Facilities and Grounds Department in the Current Expense Fund.
- Delete Fund 171-000-000, Walker Park; Fund 172-000-000, Union Park; and Fund 173-000-000, Foothills Park. These three funds will become programs in the Tourism and Recreation Department. Delete Fund 400-000-000, Combined Sewer & Water; and establish Fund 410-000-000, Harstene Pointe Sewer & Water; Fund 411-000-000, Rustlewood Sewer & Water; and Fund 412-000-000, Beards Cover Water. These new funds will account for the resources and use of resources for each of these sewer and/or water systems and will eliminate manual record keeping.
