1999 BUDGET

SUPPLEMENTAL APPROPRIATION - NOTICE OF HEARING

WHEREAS, by reason of conditions which could not be reasonably foreseen at the time of making the budget for the year 1999, it is necessary to make provision for supplemental appropriation to the budget as required by RCW 36.40.100, and RCW 36.40.195 due to: A refund from WSU to Cooperative Extension to be used for training programs; WA St Military Dept, FEMA ,and Federal Dept of Transportation grants plus revenue from the sales of brochures to be used by Emergency Management for operating expenses; a grant from the Dept of Ecology to be used by Planning for an avulsion study; unbudgeted beginning fund balances in the Current Expense Fund and Health Services Administration Fund to be used for vacation leave payouts; building code violation fees to be used by the Abatement Fund for abatement purposes, and interfund charges for services from Mason Lake Aquatic Weeds Management Fund to Health Services Administration Fund.

THEREFORE, BE IT RESOLVED by the Board of County Commissioners:

That the **22nd day of June, 1999 at the hour of 7:30 p.m.** ^{7:30 p.m. JWS MJC} in the Mason County Commission Chambers, at Courthouse Building 1, 411 North Fifth Street, Shelton, Washington, is hereby fixed as the time and place for a public hearing upon the matter of the supplemental appropriation to the budget for:
