
WHEREAS, the Board did set a date for public hearing on the matter and directed the Clerk to prepare notice thereof for posting and publication;

DESCRIBE LOCATIONS:

Parcel #1 (Proposed roads to be vacated for Jurges Enterprises, Inc.)

The entire south 30 feet of Atwater Avenue beginning at the centerline of Ninth Street adjacent to the north side of Blocks 44, 45, and 46 ending at the centerline of Sixth Street. The entire south 30 feet of Congress Avenue beginning at the east side of Tenth Street adjacent to the north side of Block 57 ending at the west side of Ninth Street. The entire 60 feet of Congress Avenue beginning at the east side of Ninth Street between Blocks 44, 45, and 46 and the north side of Blocks 56, 55, and 54 ending at the west side of Sixth Street. The entire 60 feet of Crogan Avenue beginning at the east side of Tenth Street between Blocks 57 and 56 and the north side of Blocks 58 and 59 ending at the west side of Eighth Street. The entire north 30 feet of Crogan Avenue beginning at the west side of Eighth Street adjacent to the south side of Blocks 55 and 54 ending at the centerline of Sixth Street. The entire north 30 feet of Griswold Avenue beginning at the east side of Tenth Street adjacent to the south side of Blocks 58 and 59 ending at the west side of Eighth Street. The entire west 30 feet of Sixth Street beginning at the south side of Atwater adjacent to the east side of Blocks 46 and 54 ending at the north side of Crogan Avenue. The entire 60 feet of Seventh Street beginning at the south side of Congress Avenue between Blocks 55 and Block 54 ending at the north side of Crogan Avenue. The entire 60 feet of Eighth Street beginning at the south side of Atwater Avenue between Blocks 44 and 45 and Blocks 55 and 56 ending at the north side of Crogan Avenue. The entire west 30 feet of Eighth Street beginning at the centerline of Crogan Avenue adjacent to the east side of Block 59 ending at the centerline of Griswold Avenue. The entire east 30 feet of Ninth Street beginning at the south side of Atwater Avenue adjacent to the west side of Block 44 ending at the centerline of Congress Avenue. The entire 60 feet of Ninth Street beginning at the centerline of Congress Avenue between Blocks 57 and 58 and the west side of Blocks 56 and 59 ending at the north side of Griswold Avenue. All of Tenth Street beginning at the centerline of Congress Avenue adjacent to the west side of Blocks 57 and 58 ending at the centerline of Griswold Avenue.

Parcel #2 (Proposed roads to be vacated for Jurges Enterprises, Inc.)

The entire north 40 feet of Mecklem Avenue beginning at the east side of Ninth Street adjacent to the south side of Block 13 ending at the west side of Eighth Street. The entire north 30 feet of Randolph Avenue beginning at the west side of Tenth Street adjacent to the south side of Block 26 ending at the west side of Block 27 extended south.

Parcel #3 (Proposed roads to be vacated for Jim and Merna Bianchi)

The entire south 30 feet of Woodbridge Avenue beginning at the west side of Seventh Street adjacent to the north side of Blocks 29 and 30 ending at the west side of Grapeview Loop Road. The entire north 30 feet of Randolph Avenue beginning at the west side Block 27 extended south adjacent to the south side of Blocks 27, 28 and 29 ending at the centerline of Sixth Street. The entire west 30 feet of Sixth Street beginning at the south side of Woodbridge Avenue adjacent to the east side of Block 29 ending at the north side of Randolph Avenue. The entire east 30 feet of Sixth Street beginning at the south side of Woodbridge Avenue adjacent to the west side of Block 30 ending at the north line of Lots 9 and 12 of Block 30 extended west to the centerline of Sixth Street. The entire 60 feet of Seventh Street beginning at the south side of Woodbridge Avenue between Blocks 28 and 29 ending at the north side of Randolph Avenue.
