

RESOLUTION NO. 9-08
AMENDING RESOLUTION 147-07 TO IMPLEMENT A
REVISED NON-UNION SALARY RANGE ALIGNMENT

WHEREAS, RCW 36.40.080 states that "...the Board of County Commissioners shall fix and determine each item of the budget separately and shall by resolution adopt the budget...";

WHEREAS, RCW 36.16.070 states that "...the Board shall fix the compensation of all employees...";

WHEREAS, the Board has approved a one-range salary increase for the Facilities Manager from range 31 to 32.

WHEREAS, the Board has approved a title change from Court Recorder/Judicial Assistant to Official Court Recorder/Judicial Assistant, and a second title of Official Court Recorder/Family Law Facilitator.

WHEREAS, the Board has approved a new classification of Parks & Trails Manager at range 34.

NOW, THEREFORE BE IT RESOLVED that the Board of County Commissioners does hereby amend the Non-Union Salary Tables effective January 1, 2008.


